Subject: **FLOOD ADVISORY – MAJOR RIVERS AND ITS TRIBUTARIES**

Reference: F.2(E)/2025-NDMA(WM/Weather Advisory)

Reference to the subject above, NDMA Tech Early Warning Team has forecasted **Moderate to Heavy rainfall** in KP, Upper and Central Punjab, Northeastern and Southern Sindh, Eastern Balochistan during next 48 hours. Under the said conditions following are the hydrological conditions for next 24-48 hours:-


- a. **Hydrological Situation For Next 24- 48 Hrs**
  - i. **Low level flows** are expected in **River Kabul** at **Nowshera** along with **low - medium** flows in its tributaries.
  - ii. **Low level** flows are expected downstream of **Tarbela Dam**.
  - iii. **Low Level** flows are expected in **Chenab River** at **Khanki**, and **Qadirabad**.
- b. **Urban Flooding:**
  - i. **In Punjab:** Lahore, Kasur, Narowal, Faisalabad, Okara, Gujranwala.
  - ii. **In Sindh:** Karachi, Hyderabad, Shaheed Benazirabad, Mirpur Khas, Sukkur, Sujawal, Thatta, Badin.
- c. **Flash Flooding:**
  - i. **River Swat** and its tributaries are likely to swell due to the ongoing weather system over **northern Pakistan** which will bring widespread rainfall and thunderstorms to most **parts** of **Khyber Pakhtunkhwa** during the **next 12 to 24 hours**.
  - ii. Increased flows are expected due to ongoing weather system in **River Hunza** and its tributaries i.e. **Kunjrab River**, **Ghujerab River**, **Chapursan River** and **Shimshal Braldu River** which are fed by glaciers.
  - iii. Increased flows are also expected in **Upper KP Chitral River** and its tributaries.

2. All concerned Federal Ministries / Departments, PDMA Khyber Pakhtunkhwa, KP Irrigation Department, Respective District Administration(s) / DDMA(s), Municipal / City Administration(s) are advised to ensure following: -

- a. Identification of **vulnerable points / at-risk communities** and devise **mitigation and safety measures**.
- b. Maintain **enhanced alert level / monitoring** of developing situation to reduce reaction / response times.
- c. All civic agencies / rescue services (Rescue 1122 / Fire Brigade / Ambulance / Civil Defense) to **remain alert and ensure availability of personnel and equipment**

during the next 48 hours, especially in at-risk areas.

- d. People living along the banks of River Kabul and its associated Nullahs to be **sensitized about expected increase of water flows**.
  - e. Timely **evacuation of at-risk population from low-lying / flood prone areas** as per Evacuation Plans and availability of shelter, food and medicines in those shelter camps.
  - f. Locals / farmers / cattle herders be **forewarned to shift cattle away from low lying areas** adjacent to River Kabul and its associated Nullahs.
  - g. Restrict vehicle movement in **low lying / at-risk areas**, close to River Kabul and its associated water channels / nullahs.
  - h. Provision of **POL for back-up generators at water pumping stations** and timely **pre-placement of de-watering equipment for de-flooding**.
  - i. DISCOs and relevant Local Administration / Departments to **ensure that necessary arrangements are undertaken** to avoid electrocution incidents and timely restoration of power supply.
  - j. Provision of **relief / medical supplies to affectees** in timely manner.
  - k. Coordinate with concerned departments for **clearance of roads** in case of any blockage / obstruction, waterlogging and pre-placing of necessary emergency equipment at vulnerable / appropriate locations.
  - l. **Travelers and Tourists** are **forewarned about risks posed at flood vulnerable locations and may be diverted to safe lay-by / waiting areas** with sufficient supply of water / food and essential medicines in case of adverse / dangerous road conditions by **Police, NH&MP and Local Administrations**.
  - m. In case of any eventuality, **Special SITREP / Update** be shared immediately with NDMA.


