Subject: SIGNIFICANT FLASH FLOOD WARNING – DG KHAN HILL TORRENTS

Flash Flood Alert is issued for Hill Torrents of DG Khan Division (Districts DG Khan and Rajanpur). Medium Level Flash Flooding is expected during the next 12 hours - up to 0800 hours on 13th August 2024. Immediate and necessary measures to be undertaken by PDMA Punjab, Irrigation Department and respective District Administration(s) / DDMA(s) and Rescue Service are advised to ensure following along with any other measures deemed necessary: -

- Maintain enhanced alert level / monitoring of developing situation to reduce reaction / response times.
- b. All civic agencies / rescue services (Rescue 1122 / Fire Brigade / Ambulance / Civil Defence) to remain alert and ensure availability of personnel and equipment during the mentioned period, especially in at-risk areas.
- c. People living in or nearby at-risk areas to be sensitized about expected increase of water flows and flash flooding situation.
- d. Timely evacuation of at-risk population from low-lying / flood prone areas as per Evacuation Plans and ensure availability of shelter, food and medicines in those shelter camps.
- e. Locals / farmers / cattle herders be forewarned to shift cattle away from low lying areas / at-risk areas.
- f. Restrict vehicle movement in low lying / at-risk areas.
- g. Provision of POL for back-up generators at water pumping stations and timely preplacement of de-watering equipment for de-flooding.
- h. DISCOs and relevant local administration / departments to ensure that necessary arrangements are undertaken to avoid electrocution incidents and timely restoration of power supply.
- i. Coordinate with concerned departments for clearance of roads in case of any blockage / obstruction, waterlogging.
- j. Travelers and tourists are forewarned about risks posed at flood vulnerable locations and may be diverted to safe lay-by / waiting areas with sufficient supply of water / food and essential medicines in case of adverse / dangerous road conditions


