An Overview of Year 2019

- 1. The year began with a drought warning in the provinces of Sindh and Balochistan with possible food shortages, related health issues and vulnerability of different segments of the vulnerable groups. Disaster landscape witnessed flash flooding in Balochistan, urban flooding in major metropolis, forest fires, the outburst of Shishper Glacial Lake, deadly cloudburst in Leswa / Neelum at the start of Monsoon in July and earthquake in Mirpur, AJ&K in September 2019. These events caused deaths and injuries besides displacing populace and impacting the livelihood of masses. Amongst forecasted events of 2019, though Monsoon remained relatively normal but still resulted in loss of life and infrastructure damages.
- 2. NDMA despite these challenges ensured that the mandated activities such as issuing guidelines / SOPs, preparation of plans, training in various fields and mobilizing logistics was undertaken proactively and with full zeal during various calamities and rehabilitation phases. Simultaneously, the aspect of advocacy and awareness was driven through GCC and implementation Directorates. To enable Pakistan in maintaining regional and international cooperation in DRR, remaining abreast with latest developments and learning from challenges being faced by other communities, NDMA engaged in and remained part of conferences, workshops, follow-up meetings and undertook media awareness campaigns.

NDMA: Organizational Genesis and Act

3. NDMA was established in 2007 as a lead agency to respond to whole spectrum (prevention, preparedness, mitigation, response, reconstruction and rehabilitation) of disaster management at Federal Level. National Disaster Management Authority (NDMA) is the executive arm of National Disaster Management Commission (NDMC). NDMA acts as an implementing, coordinating and monitoring body as per National Policy.





disaster management related Acts; including Civil Defence Act 1952, National Calamities Act 1958, ERRA Act 2011 and NDM Act 2010, in order to formulate one comprehensive disaster management legislation at national level. Accordingly, NDMA revised the Act and processed it for input from relevant stakeholders. The proposed amendments in NDM Act, 2010 were considered. The revised Act is reconfigured to cover all the aspects i.e. predisaster to post-disaster and in addition to subsume ERRA into NDMA.

5. The draft bill was submitted to Cabinet Committee for Disposal of Legislative Cases (CCLC), after due vetting by Law and Justice Division, for its recommendation to the Cabinet for approval of NDM Act (Amendment) Bill, 2019. CCLC in its meeting held on 19th June, 2019 deferred consideration of the proposed amendment in NDM Act, 2010 with the direction to start the process of getting a Resolution passed by the Provincial Assemblies in terms of Article 144 of the Constitution of Islamic Republic of Pakistan. Accordingly, NDMA requested all Chief Ministers to pass a Resolution from respective Provincial Assemblies.









RESPONSE TO DISASTERS

- 6. In 2019, Pakistan faced various natural calamities and NDMA maintained the lead role as a Federal Body to address the whole spectrum of disaster management. The district and provincial bodies and all concerned stakeholders were kept in intimate coordination. The calamities, their affects and the response measures taken in each case are covered in succeeding paras.
- 7. <u>Drought January 2019</u>. Based on rainfall data, PMD issued 3x Drought Alerts / Warnings for Sindh and Balochistan. 8x Districts of Sindh (Tharparkar, Umerkot, Dadu, Thatta, Sanghar, Qamber Shadadkot, Jamshoro and Badin) with approximately 3 Million population were projected to be affected. In Balochistan, 18x Districts (Pishin, Killa Abdullah, Noshki, Chaghi, Kharan, Washuk, Panjgur, Kech, Jhal Magsi, Awaran, Zhob, Jaffarabad, Barkhan, Quetta, Killa Saifullah, Kohlu, Naseerabad and Kachhi) with approximately 1.4 Million population was likely to get affected.

a. Response Measures

- (1) To proactively monitor and coordinate the developing situation of drought, "Operations Wing" of NDMA was declared as 'Drought Directorate'. Response directorate and Recovery & Rehab directorate were merged to undertake the assigned task.
- (2) To ensure proactive approach all stakeholders were kept informed through situation reports and a 'projected shortages' list was prepared. The list enabled timely procurement of food and fodder after approval from honorable PM.
- (3) To regulate collection of data, NADRA was approached to provide exact number of 'Head of Families' of affected areas.
- (4) NDMA organized a seminar focused on devising short and long term remedial measures. The seminar was conducted in Karachi to highlight the projected threat to eight districts of Sindh, especially Tharparkar.





- (5) GCC NDMA convened a 'National Consultative Workshop' in January 2019 to facilitate Government of Pakistan and other stakeholders to have an overview of drought trends, intensity and develop a better understanding of the situation.
- (6) NDMA also notified 6x Working Groups (WGs) at federal level to be cochaired by respective Federal Ministries.
- 8. <u>Flash Flooding March 2019</u>. Flash Flooding was reported in seven districts of Balochistan (Kachi, Pishin, Duki, Khuzdar, Barkan, Gwadra and Lasbela) on 10th July 2019. The event resulted in loss of 10 lives and injured 11 persons. A total of 52 x houses and 2 x bridges were damaged. A loss of 170 x livestock was also reported. The weather forecast/ warnings were timely shared with all stakeholders to enable commencement of essential preparations. PDMA Balochistan requested for relief items, worth Rs 204.053 million. The items included tents, blankets, plastic sheets, tarpaulins, water coolers and food packs. NDMA provided these items, details are attached as **Annexure-A**.
- 9. <u>Shishper Glacier May 2019</u>. The Shishper Glacial Lake in District Hunza was created after the glacier surge in 2018 and remained largely in-tact for approximately 7 months until 20 June 2019 when natural water channels opened and discharge of water from lake began. This process continued until midnight of 22nd June 2019, where maximum outflow of lake water led to damaging in-take chamber and channel of Hasanabad Hydropower Project, eroded fruit orchards on both sides of Hasanabad Nullah, damaged Karakorum Highway at two points and damaged clean water supply schemes for towns of Hasanabad and Murtazabad. No loss of human life was reported.
- 10. <u>Cloudburst/ Flash Flooding July 2019</u>. Cloudburst in Leswa Village, District Neelum on 14th July 2019 wreaked havoc, causing 20x deaths and 10x injuries. 135x houses, 2x mosques, 8x schools, 2x BHUs, 10x water mills, 14x water supply schemes, 6x bridges and 7kms of road was damaged along with loss of 56x cattle head. Leswa Bazar was completely washed away which included 42x shops and 6x stores.







a. Response Measures

- (1) NDMA Mobile Ops Room (including 2 x officers) were deployed for coordination of relief activities and damage assessment while maintaining close coordination will all concerned.
- (2) 500x Tents, 800x Blankets, and 100x Food Packs (21 kg each) were distributed by NDMA in Leswa.
- (3) Search operation conducted/ coordinated by SDMA through Pak Navy and Pak Army divers for reported drowning cases in Neelum River.
- (4) 2 x relief and 2 x medical camps were established by District Administration Neelum.
- (5) C&W and FWO mobilized heavy machinery to clear the debris including road clearance.
- 11. <u>Monsoon 2019</u>. During Monsoon 2019 (July to September) average/ close to normal rainfall was recorded across the country. The seasonal rainfall was close to normal over Balochistan and Punjab whereas below normal over GB, KP and AJ&K while above normal over Sindh. Monsoon caused 235 x deaths, injured 169 x persons. 403 x partially damaged houses and 272 x houses were fully damaged. Following significant events were reported during Monsoon 2019:
 - a. Flash Flooding/ GLOF in Golain Valley, District Chitral on 5th July 2019.
 - b. Cloudburst/ Flash Flooding in Leswa Village, District Neelum on 14th July 2019.
 - c. Urban Flooding in District Lahore on 16th July 2019.
 - d. Urban Flooding in Karachi on 29th July and 10th August 2019.
 - e. Land sliding in Naltar Bala and Naltar Paeen, GB on 8th August 2019.
 - f. Land erosion along left bank of River Indus in D.I. Khan on 10th August 2019.





- g. Flash flooding/debris flow in District Skardu on 13th August 2019.
- h. Landslide in Tehsil Hajira, District Rawalakot on 17th August 2019.
- i. Riverine Flooding in Punjab along River Sutlej from 18 25th August 2019 due to release of water from India in upstream River Sutlej.
- j. Tarbela reservoir reached at its maximum capacity from 21st August to 11th September 2019.

k. Response Measures

- (a) National Emergency Operation Centre (NEOC) and Army Flood Control Centres (AFCC) were activated for round the clock monitoring of developing situation in the country.
- (b) 2x Helicopters were provided by Pak Army for assisting PDMA KP. 4x doctors along with medicines, volunteers and food packets were dropped in the affected area.
- (c) Weather system, flow in Eastern/ Western Rivers and their tributaries and status of reservoirs (Terbela and Mangla) were continuously monitored by all stakeholders.
- (d) Dissemination of weather alerts and warnings were coordinated in the form of SMS to communities in vulnerable areas. Moreover, daily SITREPs were shared with all stakeholders.
- (e) Timely displacement of heavy earth moving machinery was ensured at key locations for clearance of landslides / debris especially along National Highways.
- (f) Relief provided by NDMA/PDMAs/SDMA/GBDMA is attached as **Annexure** 'B'.







12. <u>Mirpur Earthquake – September 2019</u>. An Earthquake of 5.8 magnitude hit parts of Districts Mirpur and Bhimber in AJ&K and Northern parts of District Jhelum, Punjab on 24th September 2019. This was followed by 2x aftershocks on 26th September and 6th October 2019, respectively. The earthquake caused 41x deaths, injured 746x persons. 7,465x houses, 141x government buildings and 4 bridges were also damaged.

a. Response Measures


- (1) Ex-Gratia Assistance, Rs 1 million each, to the next of kin/ legal heir of the deceased was granted. The financial effect was equally shared by GoP and GoAJ&K. NDMA disbursed Rs 20.5 million among the next of kins of earthquake victims.
- (2) Team from PIMS consisting of 9x doctors, 3x paramedics, 3x ambulances, 200x basic lifesaving surgical kits were deployed in the affected areas.
- (3) Polyclinic mobilised a portable X-ray machine which NDMA shifted to DHQ Hospital Mirpur.
- (4) NDMA in collaboration with UNFPA & UNICEF established four Women and Child Friendly Centres (WCFC) in villages Nakkah, Mora Roshan Sang Kikri, Samwal Sharif and Afzalpur, to reach out to the most vulnerable population in the affected areas.
- (5) Rescue 1122 Punjab team was also mobilized and deployed in affected areas.
- (6) NDMA dispatched relief items and 8 x field teams to affected areas from 25th September 2019 for initial assessment and coordination of relief activities.
- (7) Relief provided by disaster management authorities, armed forces and other relevant stakeholders is attached at "Annexure-C."





13. Losses/Damages

 a. <u>Monsoon 2019</u>. During Monsoon 2019, rains caused collapse of houses, floods (riverine floods, flash floods and urban floods), landslides and avalanches.








b. **Earthquake 2019**. Earthquake in AJ&K caused both human and infrastructure losses/ damages. Summary of causalities and damages is as under:—

14. Activities of Recovery and Rehabilitation Directorate

- a. Establishment of Women Friendly Spaces at Mitthi, Tharparkar, Sindh under SOPs developed by NDMA for prevention of possible GBV cases during emergencies.
- b. Enumerator's Training on Multi Sector Initial Rapid Assessment (MIRA) Guidelines was conducted in 10 x districts and NDMA successfully trained 509 x officials of DDMAs and line departments.
- c. Training of Trainers (ToT) for The NDMA's "Guidelines for Minimum Standards of Relief in Camp" and Enumerator's Training on Camp Coordination and Camp Management (CCCM) was held from 29th April to 3rd May 2019 at Karachi.
- d. Seasonal Livelihood Programme (SLP) trainings were conducted in 5 x districts i.e. Khyber, Umerkot, Mohmand, Orakzai and Killa Abdullah. Steering Committee and Technical Working Group approved the reports after thorough discussions and final report is in the publication process.
- e. 8 x NOCs for exemption of duties on the import of relief items were issued to Government Departments and NGOs/ INGOs for distribution amongst the affectees of disaster/ calamities.
- f. A total of 45 x applications of affectees were received for grievances of their losses on account of various disasters/ calamities directly by individuals or through Prime Minister's Public Affairs and Grievances Wing, Ministry of Parliamentary Affairs, President Secretariat, MNAs, Senators and others. These were forwarded to concerned PDMAs for redress/ necessary response.

DISASTER PREPAREDNESS

- 15. Monsoon 2019. Following activities were conducted before the onset of Monsoon:
 - a. Organized National Post Monsoon Review Conference 2018 on 12th December 2018.
 - b. Organized National Monsoon Preparedness Conference 2019 on 25th June 2019.
 - c. Prepared National Monsoon Contingency Response Plan 2019.
 - d. Activation of NEOC for Monsoon Season 2019.
 - e. Demand of Flood Fighting Equipment by Pak Army was met in part by PDMAs.

 The balance demand is being pursued by NDMA.
 - f. Provision of dedicated aviation assets for NDMA for relief and rescue operations was processed but could not be finalized. Currently, 2 x helicopters of 6 Aviation Squadron are at disposal of NDMA, when required.
- 16. **Revision of National Disaster Response Plan (NDRP)**. NDMA with the financial assistance from ADPC/ NHN took the initiative for revision of NDRP-2010 to align the Disaster Response Plans with latest disaster situation/ environment, experiences and organizational changes in Government Departments. The Plan had been prepared/ analysed by NDMA in December 2018 and was launched on 29th March 2019.
- 17. <u>Prevention of Forest Fires</u>. Forest Fires have become frequent across the country, especially in areas like Margalla Hills, Murree & Galiyat Hills and Lehtrar Range. In order to efficiently handle fires on Margalla Hills, a coordination meeting was held at NDMA on 2nd April 2019. Metropolitan Cooperation Islamabad (MCI) is working on establishment of 5x firefighting stations on Margalla Hills as recommended by NDMA. MCI forwarded details of equipment/ stores required for fire stations which are under consideration at NDMA. Signing of MoU between NDMA & MCI is also under process.





- 18. **Exercise Barracuda-X**. A Barracuda-X; Oil Spillage Containment Exercise, was held at Karachi under the overall control of Pakistan Maritime Security Agency (PMSA) from 2-4 December 2019. All the stakeholders including NDMA and representatives from PDMA Sindh and Balochistan attended the exercise.
- 19. <u>Tsunami Preparedness Guidelines</u>. NDMA is in the process of developing National Policy Framework Guidelines on Coastal Earthquake and Tsunami Hazards with the cooperation of UNDP. In this regard, a national stakeholder's conference on Coastal Earthquake & Tsunami Preparedness and Policy Framework was held at NDMA. The Policy document is under preparation.

20. <u>Establishment of Pakistan Resilience Partnership (PRP)</u>

- a. At regional level six countries of Asia (Cambodia, Myanmar, Nepal, Pakistan, Philippines, and Sri Lanka) have established the Asian Preparedness Partnership (APP) for enhancing the capacity for emergency preparedness and response in Asia.
- b. PRP meetings were conducted on 28th March 2019 and on 2nd April in 2019 to monitor progress of the activities. The following activities were planned/conducted in year 2019 under Pakistan Resilience Partnership:—

- (1) <u>Humanitarian Resilience Journal</u>. Following topics were published in the journal:—

- (2) <u>Supporting Academia in Research</u>. Research work by students from Department of Development Studies, COMSATS University PRP supported, paid honorarium to 7 x students for data collection and traveling along with related expenditures.
- (3) <u>Provincial Plan for Balochistan and Sindh</u>. Provincial disaster response plan for the Province of Balochistan and Sindh were developed in consultation with an NGO "HANDs Pakistan".
- 21. <u>Logistic Aspects</u>. During various disaster situations, details of relief stores issued to different federating units are attached as **Annexure D.**

DISASTER RISK REDUCTION

- 23. <u>Memorandum of Understandings signed by NDMA</u>. During 2019, Implementation Directorate encouraged collaborations between NDMA and multiple national and international stakeholders to further the national DRM agenda. NDMA and PMSA have acknowledged that cooperation among key disaster management partners provides a coordinated emergency response mechanism to deliver support to ensure holistic disaster management. The MOU between NDMA and PMSA was processed and signed to enhance mutual cooperation and strengthen resilience against natural disasters and calamities at sea in the Maritime Zones of Pakistan in order to protect valuable National Assets and save precious lives.
- 24. <u>PC-1s Prepared and Submitted to Planning Commission of Pakistan.</u> The following PC-1s have been prepared by DRR wing and the same were submitted to Planning Commission of Pakistan for funding through Public Sector Development Program (PSDP). Details are as under:
 - a. Implementation of Human Resource Development Plan (HRDP) Through National Institute of Disaster Management.
 - b. District-level Multi-Hazard Vulnerability and Risk Assessment (MHVRA) of Pakistan.
 - c. Establishment of National Disaster Response Force (NDRF).
- 25. <u>Activities funded through Sustainable Development Centre (SDC)</u>. The following activities were under taken through SDC project by DRR wing with details which are:
 - a. <u>DRR Preparedness & Response Planning Training</u>. Implementation Directorate assisted NIDM financially through SDC project to organize 15 x DRR Preparedness & Response Planning Training, in which 653 official were trained from government, NGO, media, academia and other stakeholders.





- b. Media Campaigns (Electronic and Print)/ NIDM Full Page Supplements in National Newspaper. A full-page color supplement of NIDM was published in two leading national daily newspapers i.e. "THE NEWS" and the "EXPRESS TRIBUNE" to raise general awareness amongst public on DRR and share the achievements/ contributions made by NDMA and NIDM.
- c. Observation of DRR Day/ National Resilience Day 2019. NDMA commemorated 8th October as National Resilience Day. This year on the directions of the Chairman NDMA, National Resilience Day was celebrated with the affectees of Earthquake, which occurred on 26 September 2019 at Mirpur, Azad Jammu Kashmir. Two events were organized, one at Nakka and other at Samwal Sharif, both being among the most affected areas of earthquake. Officials from NDMA participated in the event.
- d. <u>Awareness through Exhibitions</u>. The Centre for Disaster Preparedness and Management, University of Peshawar organized a one day Expo on Technology Mediated Disaster Risk Reduction, Climate Change Adaptation and Sustainable Development at PUTA Hall on 25 May 2019. NIDM participated in the exhibition by setting up its stall where knowledge products and capacity building services and contributions of NDMA/ NIDM were showcased. A large number of visitors and dignitaries visited the NIDM stall and appreciated the efforts made by NDMA/ NIDM.
- e. <u>Printing of Coffee Table Books</u>. Printing of Coffee Table (Success Stories) Book titled as "The Story- a Journey through Resilient Pakistan" was envisioned and developed to pay tribute to the resilient people of this Nation, in the wake of natural and human-induced catastrophes.
- f. <u>Strategic Planning Workshops</u>. NDMA/ NIDM on 30th and 31st July 2019 organized the Strategic Planning Workshops. Prime objective of the workshops was to consult the stakeholders for developing first ever "Strategic Plan" of NIDM. Representatives from government departments/ authorities/ institutes,







academia, corporate sector, UN system, INGOs, NGOs and media participated in the workshops.

26. Building Disaster Resilience in Pakistan (BDRP) Programme

- a. Regular BDRP Programme Steering Committee meetings were organized by DRR Wing. BDRP Programme Steering Committee (PSC) had been established at national level to oversee programme interventions; provide policy guidelines & strategic directions; improve coordination and coherence and ensure BDRP results and outcomes integration within key sector and government line ministries at national, provincial and district levels.
- b. The Programme, in Phase-I, benefitted a total of 527,016 persons (Male: 269,590, Female: 257,425, PWD: 263,49, Older: 347,59) through providing inputs on CBDRM, WASH, Infrastructure and Livelihoods and as per MTR findings this successfully improved resilience of 33% targeted households. In Phase-II, the following achievements were made:-
 - (1) Agro-Ecological Zoning (AZE) for Punjab and Sindh delineated using climatic, soil, water, crop norms and economic variables.
 - (2) Drought Early Warning System- Implementation of Agriculture Stress Index System (ASIS).
 - (3) Drought Mitigation Policy and Operational Plan for Sindh.
 - (4) District and Provincial Agriculture Disaster Risk Management Operational Plans (ADRMOPs).
 - (5) District DRM Plans prepared for 4 districts.
 - (6) MHVRA developed for 2 districts.
 - (7) National Plan of Action for SFDRR in Pakistan first draft prepared.
 - (8) Provincial strategy on Public Private Partnership.





- (9) Establishment of four Emergency Operation Centres.
- (10) School Safety Training Material prepared.
- (11) Formation of CBDRM Structures (VDMCs and UCDMCs).
- (12) Risk and Resilience Assessment at UC level and development of UCDMPs.
- (13) Exposure Visits of UCDMCs, VDMCs and other stakeholders.
- (14) Capacity Building of Community Structures, Setting up EWS, Provision of Emergency Response Toolkits, Hygiene promotion, sensitization and public awareness.
- (15) School Based Disaster Risk Management, Hygiene Promotion and health staff training on emergency preparedness.
- (16) Construction/Rehab of medium to large scale UC level DRR/ Livelihood infra schemes.
- (17) Construction of disaster resilient household shelters and hand pumps.
- (18) Capacity building of farmers on CSA and Conservation Agriculture Based Technologies and Practices.
- (19) Community Based Quality Seed Production & Multiplication with storage facility.
- (20) Promotion of Improved Household Nutrition through vegetables production and Training.
- (21) Promotion of High Value Crops (vegetable production).
- (22) Community Based Nurseries for Quality Seedling and Plants Production, Promotion of agro-forestry trees.







- (23) Market assessment, vocational skill trainings, strengthening the capacity of small to medium entrepreneurs to enhance access to the market and MFIs.
- 27. <u>Certification from INSARAG</u>. INSARAG is the official certifying body of United Nations Office for Coordination of Humanitarian Affairs (UNOCHA). This is a network of disaster-prone and disaster-responding countries and organizations dedicated to Urban Search & Rescue (USAR) and operational field coordination. It aims to establish standards and classification for international USAR teams. Pakistan became the first country in South Asia to be certified from the United Nations International Search and Rescue Advisory Group (INSARAG) External Classification (IEC). The certification has enabled the Pakistan Rescue Team of Emergency Services Academy, Rescue 1122, Lahore to conduct search and rescue operations anywhere in the world. NDMA provided critical support to Rescue-1122 during the entire process.
- Monitoring & Reporting Cell at NDMA. SFDRR Monitoring and Reporting Cell was established under DRR Wing, NDMA, with the support of UNDP Pakistan, to monitor and report progress on the status of SFDRR targets and implementation of SFDRR in the country. SFDRR Cell was operationalized in September 2020 and has undertaken inventory of existing SFDRR progress reporting data available, identified required information to collect and updated UNDRR on the progress through Ministry of Foreign Affairs' Geneva Mission. Furthermore, officials from NDMA/ SFDRR Cell held advocacy meetings with provincial disaster management authorities (PDMAs) from Punjab, KP and Sindh on the sidelines of training events, to initiate contact with provinces regarding SFDRR monitoring and apprised PDMAs on the planned project activities to be completed with the support of provincial authorities.
- 29. <u>Provincial level Trainings on 'Disaster Risk Resilience through Climate Change Adaptation'</u>. Implementation Directorate, NDMA, with the support of UNDP Pakistan and NIDM, successfully conducted 3x trainings on 'Disaster Risk Resilience through Climate Change Adaptation' at the provincial level. The trainings were conducted in Lahore, Peshawar and Karachi. Through these 3x trainings, NIDM/NDMA trained more





than 100x participants representing provincial government departments and civil society organizations.

- 30. <u>Development of 'Pakistan DRM Status Report 2018–19</u>. Implementation Directorate NDMA prepared Pakistan DRM Status Report 2018 19, as per international SFDRR obligations which was shared with concerned stakeholders.
- 31. <u>Successful completion of SDC Funded Project</u>. DRR Wing, NDMA successfully concluded the project titled "Institutional Strengthening of NIDM" funded by Swiss Development Cooperation (SDC).
- 32. <u>Capacity Building Exercises with Multiple Stakeholders</u>. Implementation Directorate has directly been involved in the capacity building initiatives organized by the National School of Public Policy, National Defence University, and WAPDA, among others.
- 33. Enhancement of PMD Weather Forecasting Capabilities. In order to enhance the capacity and weather forecasting capabilities of Pakistan Meteorological Department (PMD), the license subscription is being paid by NDMA since last 2 years and this year again on the request of PMD, DRR Wing moved the case for the license renewal for continuous efficient weather forecasts. This case has since been approved and Pakistan Metrological Department (PMD) has procured the same with necessary payment procedures in hand with Finance Directorate.
- 34. National Institute of Disaster Management (NIDM) Activities. All the activities including, but not limited to, trainings and workshops, conducted by NIDM were supported through DRR Wing. NIDM was successfully supported in implementation of its activities as per the work plan. During the reporting period 15x training was conducted where 558x individuals from government, academia, media and humanitarian sector were trained.
- 35. <u>International Organization for Migration (IOM)</u>. International Organization for Migration (IOM) and NIDM jointly organized 2x trainings on "Disaster Resilient Shelter Design and Construction Practices" at Islamabad and Karachi respectively where 54 officials were trained on the subject. A permanent "Model Disaster Resilient Shelter" was







also constructed at NCRD (Islamabad) premises for practical learning of the trainees in future.

- 36. <u>JICA's Project on Capacity Development of Disaster Management Institutions in Pakistan</u>. A series of meetings were held between NDMA officials and JICA consultants regarding Implementation of the Project. JICA dispatched long-term consultants to implement the project. The project implementation schedule is from 2018- 2021. The objectives of the project are:
 - a. Improving the training management system in NIDM from the perspective of National Human Resource Development Plan of NDMP.
 - b. Improving the trainings delivered by NIDM and training evaluation process.
- 37. MHVRA. Earthquake, Drought and Landslide hazard assessment had been conducted in 8 x districts of KP (Swat, Shangla, Nowshera, Kohistan Charsada, Upper Dir, D.I. Khan & Buner) K.P and 7 x districts of Balochistan (Jaffarabad, Sohbatpur, Sibi, Nasirabad, Kachi, Quetta & Gawadar) of Balochistan The activity covered the following modules:-
 - (1) Analysis of all spatially and temporally relevant hazards in the study district including those emerging along with climate change.
 - (2) Exposure Analysis with identification of all tangible and non-tangible elements at risk to include population, buildings, critical and essential infrastructures, transport and livelihood.
 - (3) Vulnerability Assessment covering both natural and climate change related impacts on physical and social dimensions of society.
 - (4) Assessment of both soft and hard capacities, to mitigate or adapt to any changes induced by the hazardous events.
 - (5) Risk Assessment driven by cumulative scoring of all multi impending natural and Climate Change related hazards, elements at risk, vulnerabilities and adaptive and coping capacities in study district.

39. International Conferences and Seminars

- a. <u>Meeting of the Regional Planning Council (RPC)</u>. NDMA provided input on agenda points of 30th RPC of ECO which was held in Tehran from 14-16th January 2019. The meeting was attended by Ministry of Planning as leading Ministry from Pakistan.
- b. Asian Conference on Disaster Reduction 2019 (ACDR2019). The Asian Conference on Disaster Reduction, ACDR2019 was organized by the Government of Turkey, the Government of Japan and Asian Disaster Reduction Centre (ADRC) on 25-27th November 2019 in Ankara, Turkey. The conference focused on exploring context-specific experiences and lessons to help address common challenges in disaster risk reduction (DRR). ACDR2019 aimed to contribute in accelerating the implementation of the Sendai Framework for Disaster Risk Reduction and the Sustainable Development Goals (SDGs) in the Asian region. NDMA attended the conference and gave valuable input.
- c. <u>Training of Tajikistan Officials on Disaster Management</u>. NDMA organized a training workshop for officials from Tajikistan in the field of Disaster Management from 2nd November to 9th November 2019. The workshop consisted of two components. In the initial phase, a 5x days training workshop was held in Islamabad where participants were provided insight into the theoretical aspects of Disaster Management. The second stage of the training








was held in Punjab Emergency Services Academy in Lahore for three days where training was provided in the field of emergency search and rescue.

- d. <u>Transformation of Asian Disaster Preparedness Centre (ADPC) as International Organization</u>. ADPC was working as Foundation, however, after ratification of charter of all founding members of ADPC, a Board of Trustees (BOT) was formed and Chairman NDMA was suggested as Member of Board of Trustees from Pakistan. First meeting of Board of Trustees of ADPC was held on 7th November, 2019 in Bangkok which was attended by Member Operations, NDMA on behalf of NDMA. Major Decisions were taken during the meeting;
 - (1) As the host country of ADPC, the chair of BOT for 2020 was given to Thailand whereas vice Chair was given to Bangladesh in alphabetical order.
 - (2) A Host Country Agreement between ADPC and Royal Thai Government has been signed. It will provide ADPC some privileges and immunities to facilitate ADPC's operation as an International Organization.
 - (3) A proposal was approved to establish a coordination committee to assist the Board of Trustees during transition into an intergovernmental organization. This Committee is established initially for two years after which it will be reviewed. Pakistan Embassy representative attended these meetings.
 - (4) The Board approved the constitution of Executive Committee of ADPC which will be chaired by the Executive Directors whereas all Directors and Chiefs of ADPC departments are members of Executive Committee.
- e. <u>Meeting of SCO Members States</u>. The Seventh Meeting of Heads of Territorial Authorities for Border Area Emergencies of the SCO Member States was held in Chelyabinsk, Russia from 18-20th September 2019. With attendance by NDMA from Pakistan side.

- b. <u>PSSF Scale-Up in ICT 2nd Phase</u>. NDMA with the support of its partners UNICEF and British Council developed the Pakistan School Safety Framework. A pilot of same has conducted across Pakistan in government and private schools. After the successful pilot it was decided to Scale-up the same in ICT as a Model with the support of Federal Directorate of Education.
 - (1) A training was held from 10th December 2018 to 4th January 2019 in 04 Batches at 7 different locations of Islamabad.
 - (2) Another workshop was conducted for Internal Evaluators Training from 21-22 February 2019 in Islamabad. It included around 30x participants; 5 from Gilgit / Baltistan, 4 from Azad Jammu & Kashmir, 3 from Quetta and 5 from Peshawar and 11 from ICT.
- c. Provincial Rollout of PSSF in Punjab, Balochistan and GB. PSSF Programme was rolled out in selected public sector schools from Gilgit, Quetta and Punjab in collaboration with Education Department GB, Education Department Balochistan and Aga Khan Agency for Habitat (AKAH). PSSF has been integrated in education Sector Plans of Balochistan. Details of trainings conducted in this regard is given below:
 - (1) A training took place from 22nd to 26th April 2019 in Gilgit in which 30 schools participated. A total of 9 Master Trainers and 83 teachers were trained.
 - (2) A training took place from 2nd to 6th May 2019 in Quetta in which 30 schools participated. A total of 6 Master Trainers and 105 teachers were trained.
 - (3) Training took place from 5-9th August 2019 in Lahore in which 35 schools participated. A total of 6 Master Trainers and 45 teachers were trained.
- d. <u>Training on Gender in Emergencies (GiE)</u>. A two-day orientation/ sensitization session on Gender in Emergencies was organized by NDMA on 17-18th April 2019 in Islamabad. 35 participants attended the workshop from NDMA, Pakistan Red Crescent Society, ERRA, National Commission of Child Welfare and Development







Department, Provincial Disaster Management Authorities (PDMA) of Sindh, Punjab, KP, Balochistan, AJK, and GB in addition to participants from Commission on Status of Women KP, Punjab and Sindh. The objective of this training is to build capacity of government officials on addressing the needs and concerns of women and children during emergencies.
