11. **Earnest Money:** The Firms are required to submit Earnest Money @ 3 million (lump sum) in the name of Director (Procurement), NDMA. However, the same will be returned in case of rejection. **Cross cheque will be not entertained.**
12. **Draft Contract Agreement:** Draft contract agreement as per appendix - A
13. **Award of Contract / Supply Order:** Competitive bidding will be done through two Stage Two Envelopes System (Technical & Financial). Financial offer will be opened for those bids who technically qualified. The firm offering overall lowest bid against items of required quantity and specifications will be awarded the Contract / Supply Order.
14. **Maximum Time of Delivery:** The selected firms would be liable to deliver their respective items within the stipulated time period. Deliveries must start after issuance of PO as follows:-
 - a. 50% Ventilators in 05 days of PO issue date (FOB, only for those countries whose Air Flights are operating to Pakistan) or CIF Islamabad in 10 x days from date of issue of PO
 - b. Remaining 50% in 07 x days from date of issue of P.O. (FOB, only for those countries whose Air Flights are operating to Pakistan) or CIF Islamabad in 12 x days from date of issue of PO
 - c. Maximum time of delivery is before 28th June, 2020
15. **Payment Terms:** Payment will be processed after satisfactory delivery of the required items as per supply contract / agreement;
 - a. Payment should be done in Pak Rupees.
 - b. Payments through LC to manufactures abroad less China is preferred option.
 - c. Payments to OEM in China may be restored through TT.
 - d. Advance payment to local dealers/supplier will only be released against equal amount of Bank Guarantee, if deemed necessary in national interest.
 - e. Partial advance payment to OEM be released after evaluation of profile of the company, recommendation of Pakistan Diplomatic Mission abroad and delivery schedule.
 - f. 5% Bank Guarantee will be deposited by local supplier/authorized dealer on account of after sales service/commissioning /training of equipment.
 - g. Separate Quote for price for FOB or CIF (whichever applicable) are required to be submitted.
