### **General Terms and Conditions**

The National Disaster Management Authority requires security services for its warehouse, located at Islamabad (8 x Guards) and Karachi (4 x Guards) for 12 hrs shift on following terms and conditions (Tender No.04/2019-20):-

1. The firm should be registered with Income Tax & Sales Tax Department (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
2. The firm should have a minimum of five (05) years' experience of providing security service and should have a proper setup / office at Islamabad / Rawalpindi and Karachi.
3. The bidder will be required to submit a Pay Order / Demand Draft @ 5% of the total value of the contract (12 x months), as earnest money in the name of Director (Administration & Procurement), NDMA Islamabad.
4. Earnest Money of unsuccessful bidders will be returned / refunded after award of contract to successful bidder(s). However, Earnest Money of successful firm(s) will be converted into "Security Deposit".
5. The firm must be a license holder issued by Ministry of Interior or any other concerned Division.
6. The bids must reach the undersigned upto 12.00 am on 30 January 2020 which will be opened at 12:30 pm on the same day in presence of representative of security agency.
7. The contract will be awarded to the lowest evaluated bidder.
8. Submission of false statement / documents as well as concealing of any information is liable to disqualify the respective firm(s).
9. During the currency of the contract, the firm will provide Security Services as per terms and conditions, to be settled later on in the shape of contract agreement between both parties.
10. The Authority reserves the right to accept or reject all or any of the tenders as per PPRA Rules.
11. Duration of contract will be for 2 x years.

12. The company shall preferably provide ex-serviceman/Police (Sepoy to Havildar) security guards under 50 years of age with good health along with physical fitness certificate.

17. The company will be responsible to provide necessary uniform, proper weapons and security gadgets to the security guards.

19. Weightage of Technical and Financial proposals will be 70% and 30% respectively.

20. During the technical evaluation no amendments in the technical proposal shall be permitted;
