National Disaster Management Authority (NDMA), Islamabad intends to invite bids from authorized distributors/ suppliers/ service providers etc duly registered with Income Tax and Sales Tax and shall be in Active Taxpayer List (ATL) of the Federal Board of Revenue for the Supply of 5000x NDMA standard food packs to be delivered in the rain/flood affected areas.

The sealed bids prepared in accordance with the terms and conditions (enclosed) shall be submitted at 1430 hours dated **17**<sup>th</sup> **August, 2025 (Sunday).** Sealed bids will be opened at 1430 hours on the same day in the presence of bidders' representatives who chose to attend in the bid opening at NDMA Headquarters Islamabad.

### Note:

- a. Atta (20 kg) should be packed separately in a waterproof polythene bag.\
- b. The remaining items must be packed in a **durable**, **weather-resistant carton of good quality**, securely sealed with heavy-duty packing tape.

#### Terms and conditions:-

- a. Quoted rates must be inclusive of all applicable government taxes, duties, and transportation costs to any location in KPK / AJK / GB. However, NDMA reserves the right to change the delivery destination to any location within Pakistan.
- b. The first batch of 1,000 food packs to be delivered on 18th August 2025 at 0500 hours at I-11 warehouse. Strict adherence to the delivery schedule is required.
- c. Items must strictly conform to the specifications and brands provided by NDMA. Where no specific brand is mentioned, the firm must clearly indicate the brand offered in the quotation. Quotations offering substandard or low-quality brands will be rejected outright.
- d. Atta (20 kg) should be packed separately in a waterproof polythene bag. The remaining items must be packed in a durable, weather-resistant carton of good quality, securely sealed with heavy-duty packing tape, ensuring safe handling and transportation under rough and challenging conditions.
- e. NDMA reserves the right to increase or decrease the quantity based on evolving requirements.
- f. Firms must clearly mention the location of their warehouse in the quotation. The warehouse should be well-maintained, hygienic, and suitable for the safe storage of food items, ensuring protection from contamination, pests, and adverse weather conditions.
- g. No advance payment will be made. Payment will be processed after full delivery, subject to a satisfactory inspection report, and after deduction of all applicable taxes.
- h. NDMA reserves the right to impose a penalty of 0.2% per day on any late-delivered quantity.
- i. Firms must mention details of their readily available stock, Daily production capacity, and estimated time required to complete the full delivery. NDMA may give preference to firms offering shorter delivery timelines.
